### Preparation and Additional Information:

#### Instructions for Preparation and Cooking:

Cook to a minimum of 165 °F . Bake in single layer in preheated convection oven at 350°F for 10-15 min. Bake in single layer in preheated conventional oven at 400°F for 15-20 min. Microwave on high about 1-2 min per serving, turning once. Adjust times to quantity being cooked and equipment used. Do not overcook.

#### Instructions for Frying:

Deep fry at 350 for 2-3 min.
