Preparation and Additional Information:

Instructions for Preparation and Cooking:

Weigh 100 grams of flakes. Weigh 550 grams of hot water (boil water in lab tea pot). Add flakes to water and very gently mix to submerge flakes in the water. Do not whip or stir. Let stand 2 minutes. Put 1 qt. pan on the stove containing 4 cups of boiling water, bring to a boil. Place the same sample into the boiling water, and bring down the heat to a simmer (medium 190-200 degrees). Set time to 15 minutes and begin timing as soon as the product is added to the water. When the timer rings, remove pan containing the product from the stove and drain through the strainer and run under cool water. Be careful not to lose any product.
